### 1 Report Details

- 1.1 Rykneld Homes Business Plan 2015/18, including Performance Indicators, supports the delivery of North East Derbyshire District Council's (NEDDC) strategic objectives.
- 1.2 The Business Plan (**Appendices 1 and 2**) was approved by Rykneld Homes Board on 26 March 2015.
- 1.3 The Plan has been jointly developed with NEDDC and local stakeholders such as tenants and involvement groups through Business Planning days.

#### 2 Conclusions and Reasons for Recommendation

- 2.1 The Business Plan is aligned to support and deliver NEDDC's proposed Corporate Plan. NEDDC's Corporate Plan outlines key strategic objectives in four areas. Pages 4 and 5 of the Business Plan identify how Rykneld Homes will deliver NEDDC's strategic objectives:
  - Unlocking Our Growth Potential
  - Developing Healthy, Safe, Clean and Green Communities
  - Providing Excellent Customer Service
  - Organisational Transformation.

The proposed indicators reflect the key service areas with appropriate targets and tolerances based on improving current performance and benchmarking against the top 50 and 25% reported performance of landlords.
