Update on Safeguarding Vulnerable Adults and Children

Purpose of the Report

- This report provides Cabinet with an update of activity around safeguarding for both vulnerable adults and children for North East Derbyshire District Council
- The report also provides an overview of the county wide Vulnerable Adults Risk Management panels (VARM) and the council's involvement in the process.

1 Report Details

- 1.1 Policies for both Child Protection and Vulnerable Adults are in place and currently fit for purpose. Updates are due later this year following the introduction of the Care Act.
- 1.2 Safeguarding Link Officers have been identified as the contact point for any referrals through to Derbyshire County Council or the police. These are:-
 - Paul Hackett Corporate Safeguarding Lead Officer
 - Carl Griffiths Lead Safeguarding Link Officer
 - Rachael Pope Customer Services Operational Manager
 - Lee Hicken Joint Assistant Director, Leisure

 - Heather Summers Head of Neighbourhood Services, Rykneld Homes
- 1.3 A joint Corporate Safeguarding Group meets on a bi-monthly basis to ensure that activity around safeguarding is coordinated and that all staff and members are aware of the process. The group involves officers from Bolsover District Council, North East Derbyshire District Council and Rykneld Homes.
- 1.4 Activities to raise awareness of policies over the last 18 months have included:
 - New staff briefing cards detailing signs of abuse, how to refer and contact details for all Safeguarding Link Officers are currently being distributed and

include aspects of mental health following the Scrutiny review of Mental Health in 2015.

- Regular bulletins on NEDi
- Dedicated Safeguarding page on NEDi
- Additional training for NEDDC Officers has been delivered by DCC and the Fire and Rescue Service on the newly developed Vulnerable Adults Risk Management process (VARM).
- A Programme of safeguarding training for Officers commenced in 2015.
 Members were also invited to attend a safeguarding awareness briefing on 9
 November 2015. Between the beginning of January 2015 and the end of January 2016 a total of 180 North East employees and 19 North East Derbyshire Members have attended safeguarding awareness sessions.
- Scrutiny Review on Sexual Exploitation commenced 25 September 2015.

Vulnerable Adults Risk Management Process (VARM)

- 1.5 The Derbyshire Safeguarding Adults Board has developed the VARM Policy to provide professionals with a framework to facilitate effective multi agency working with vulnerable adults who are deemed to have mental capacity issues and who are at risk of serious harm. These are vulnerable adults who do not meet DCC's Safeguarding Adults process but who do need to be considered and risk assessed via another process. It doesn't replace other existing processes such as the Mental Health Act or MARAC (Multi Agency Risk Assessment Committee for domestic abuse cases at risk of homicide).
- 1.6 The VARM process is a multi agency approach designed to discuss, identify and document high risk cases, and formulate an action plan identifying appropriate agency responsibility for actions. The VARM panel is chaired and coordinated by an initiating Officer.
- 1.7 Key agencies involved include Adult Safeguarding, Derbyshire Fire and Rescue. Derbyshire Constabulary, Environmental Health Officers, Housing, Probation, Alcohol and Drug Services. Each agency is required to nominate VARM champions. NEDDC has nominated the following:

Carl Griffiths – Private Rented Sector and Housing Options Manager Gill Halliwell – Senior Environmental Health Officer Jayne Hooton – Senior Environmental Health Officer Rykneld Homes have an additional 2 Officers

1.8 Both the Council and Rykneld Homes have been increasingly involved in recent VARM cases since January 2014 and have often acted as the lead agency.

Safeguarding and VARM Referrals

Child Protection

North East Derbyshire District Council

1.9 There have been 6 child protection referrals between the period November 2014 and November 2015 plus 1 anonymous contact via the website asking for advice on reporting suspected abuse but no details given.

- 1.10 The following factors were recorded:
 - 3 were allegations of neglect and young children being left alone in the house;
 - 1 was an allegation of grooming;
 - 1 physical abuse witnessed in the form of a child being hit;
 - 1 allegation of sexual abuse.
- 1.11 Referrals came via a cross section of departments including Revenues and Benefits, Leisure Centre, Environmental Health and the Contact Centre.

Rykneld Homes

- 1.12 There have been 5 child protection referrals during the period November 2014 November 2015.
- 1.13 The following factors were recorded:
 - Parental Neglect 3
 - Domestic Abuse 1
 - Substance Misuse by parents 1

Adult Safeguarding

North East Derbyshire District Council

1.14 There have been 7 cases of adult Safeguarding between the period November 2014 to November 2015

The following factors were recorded:

- 1 threats of suicide to an Officer within Revenues and Benefits:
- 1 gentleman with learning disabilities with suspected abuse/hate crime from neighbours;
- 1 Learning disabilities, robbed and attacked by neighbours;
- 4 elderly, mentally and physically vulnerable, including financial abuse

Rykneld Homes

1.15 There have been 15 adult safeguarding referrals for the period November 2014 to November 2015.

The following factors were recorded:

- General Welfare 1
- Mental Health 6
- Mental/Physical Health 2
- Physical abuse 1
- Domestic abuse 2
- Substance misuse 2
- Financial abuse 1

Domestic Abuse

- 1.16 Derbyshire County Council do not include domestic abuse under their Safeguarding Vulnerable Adults Policy. Alternative mechanisms are in place to respond to domestic abuse including direct referrals to Derbyshire Domestic Violence and Sexual Abuse Services (DDVSAS formerly North Derbyshire Women's Aid), the police or MARAC (Multi Agency Risk Assessment Committee).
- 1.17 The council and Rykneld Homes monitor incidents or suspected incidents of domestic abuse:

North East Derbyshire District Council

1.18 During the period October 2014 – October 2015 the Council's Housing Options Team dealt with 62 cases where domestic abuse was a factor. The team continues to liaise closely with DDVSAS and refer to their services which include advice sessions, refuge accommodation, Men's Refuge, outreach services and services for children.

Rykneld Homes

1.19 Rykneld Homes referred **3** cases of domestic abuse directly through to Derbyshire County Council or DDVSAS.

Vulnerable Adult Risk Management Meetings (VARMS)

North East Derbyshire District Council

1.20 Council Officers from the Housing Options Team and Environmental Health Services have and are currently involved in 5 VARM meetings with Environmental Health staff chairing 2 of those meetings. **Appendix 1** provides an overview of the types of cases Environmental Health are involved in and **Appendix 2** provides photographs of some of the properties affected.

Factors include

- Hoarding this is a growing issue. Rykneld Homes have recently developed its own Hoarding Policy in response to the issue and the Derbyshire Fire and Rescue Service are actively working to promote the development of a Derbyshire wide Hoarding Policy and Procedures. Hoarding will usually result in a high risk of fire and high costs due to need to clear properties.
- Hazardous conditions but non engaging with services. Issues of lack of nourishment and sanitation. Vulnerability due to old age, learning disabilities and mental health are factors also in these cases.

Rykneld Homes

1.21 Rykneld Homes have been involved in 3 VARMs during the period November 2014 to November 2015.

These include

- Mental Health and Anti Social Behaviour 2 including one case where there
 was a high risk of fire due to dangerous smoking
- Hoarding 1 case

2 Conclusions and Reasons for Recommendation

- 2.1 To provide an overview and update on incidence and activity around the Council's Safeguarding Vulnerable Adults and Child Protection Policies.
- 2.2 To highlight the VARM process and the Council's involvement and contribution in preventing serious harm and risk of death to vulnerable individuals and their neighbours.

3 Consultation and Equality Impact

- 3.1 An Equality Impact Assessment was carried out on both the Council's Safeguarding Vulnerable Adults Policy and Child Protection Policies.
- 3.2 A VARM panel is a multi agency group to ensure that the right agencies are engaged in preventing serious harm to vulnerable adults in the district.

5 Implications

5.1 Finance and Risk Implications

- 5.1.1 The risks of not having adequate safeguarding processes in place are to the safety of vulnerable adults and children and in some cases prevention of death occurring.
- 5.1.2 The VARM process has proved effective in preventing fire to a property and neighbouring properties.
- 5.1.3 A number of VARM cases have resulted in the need for financial resources to help clear properties where hoarding is a factor. Officers seek to identify and apply for funding from external agencies. The Council successfully applied on behalf of Derbyshire Housing Officers for funding for assistance with VARM cases. There is currently a pot of £10,000 across Derbyshire to help facilitate the VARM process.

5.2 Legal Implications including Data Protection

5.2.1 Section 11 of the Children's Act 2004 states that district and borough councils have a "duty to co-operate" and a "duty to safeguard and promote well being" for children. Councils should ensure that their functions and services are discharged with regard to the need to safeguard and promote the welfare of children. The Council along with Bolsover District Council and Rykneld Homes undertake a review of activities against the Section 11 criteria through the use of an audit tool.

5.3 <u>Human Resources Implications</u>

- A total of 180 employees have attended safeguarding awareness training between the beginning of January 2015 and end of January 2016, with two further sessions due to be held in February 2016. This training has been delivered by Safeguarding Children Training and Consultancy Ltd.
- It should be noted that the VARM process can involve an intensive period of Officer time, and on occasion a number of council Officers will be involved in panels at the same time. For example one recent case included Officers from Environmental Health Services, Housing Options Team, Community Safety and the Legal team.

6 Recommendation

6.1 That Cabinet note the work carried out by Officers to safeguard vulnerable adults and children and where appropriate to ensure that the police or Derbyshire County Council's Adult Social Care and Children and Younger Adults (CAYA) are made aware of the incidence as part of their safeguarding duties.
