Purpose of the Report

 To update Growth Scrutiny Committee on the A61 Corridor Scrutiny Review – Action Plan

1 <u>Report Details</u>

- 1.1 There is an action plan from the A61 Corridor Scrutiny Review with some outstanding actions. These are as follows:
 - That the A 61 Corridor Strategy by completed and published, which sets out the long term vision for the project, after it has been approved by Derbyshire County Council
 - That an up to date map of the A61 Corridor Project be produced showing the areas identified for improvement along the whole route
 - That further communications are made with the public to highlight progress with this project and the interventions it is making or planning to make and the amount of funding being provided
- 1.2 The first recommendation has been completed and this can be found <u>here</u>. This report is in the public domain and shows the strategy and associated costs for the Avenue (and the wider A61 Growth Corridor projects).
- 1.3 The target timetable for the Avenue is set out below:

- 1.4 DCC have not yet produced a map showing the areas identified for improvement along the A61 but they have been highlighted in the investment strategy.
- 1.5 DCC will be carrying out public communications on a scheme by scheme basis, but DCC will be looking at a communications strategy to inform when these should occur and to ensure they are coordinated, now DCC have confirmed the strategy.
