#### 12 Scrutiny Annual Report 2014/15

Council considered a report of the Scrutiny Chairs which set out the work undertaken by Scrutiny in 2014/15.

Three scrutiny reviews were carried out in the year in respect of anti-social behaviour in young people, mental health services and working with town and parish councils. A number of recommendations were made for improvement which were considered by Cabinet on 15 April 2015 and accepted. The recommendations would now be translated into action plans for delivery.

In addition, the committees had been monitoring the delivery of action plans from previous scrutiny reviews around child poverty, the joint ICT service, the allocations experience and relationship between the Council and Rykneld Homes and progress against these action plans had been satisfactorily completed and the reviews signed off.

Throughout the year, Scrutiny continued to be involved in policy development work. As part of that committees had received updates on various policies and strategies covering service delivery.

Details of the work of the Joint Scrutiny Panel with Bolsover and Chesterfield Councils was also set out in the report.

#### 13 <u>Proposed Arrangements for Scrutiny at North East Derbyshire District</u> Council – May 2015 onwards

Council considered a report of the Scrutiny Chairs, which proposed reorganisation of the Scrutiny Committee structure from May 2015.

The existing scrutiny committee structure which was established in 2007, comprised four committees:-

- Audit and Corporate Governance
- Economic Regeneration, Skills and Environment
- Healthy Communities and Well Being
- Safer Homes and Neighbourhoods

The proposal was to disestablish the Economic Regeneration, Skills and Environment Scrutiny Committee, Healthy Communities and Well Being Scrutiny Committee and Safer Homes and Neighbourhoods Scrutiny Committee and create three new scrutiny committees around Growth, Communities and Organisation to align with the Corporate Plan.

#### **RESOLVED** that:-

- (1) Three new Scrutiny Committees be established with new terms of reference aligned with the Corporate Plan 2015-19 as follows:-
  - Growth
  - Communities
  - Organisation
- (2) The Audit and Corporate Governance Scrutiny Committee continue to operate within its existing terms of reference.
- (3) The Economic Regeneration, Skills and Environment Scrutiny Committee, the Safer Homes and Neighbourhoods Scrutiny Committee

and the Healthy Communities and Well Being Scrutiny Committee not be established.

#### 14 Calculation of Political Balance and Allocation of Committee Seats

Council considered a report of the Assistant Director – Governance and Monitoring Officer, which sought Council's approval of the allocation of seats on committees in accordance with the statutory requirements concerning political balance.

Following the elections held on 7 May 2015 the political balance of the Council was:-

For the purposes of calculating the entitlement of each political group to seats on committees, in line with the statutory regulations, it was proposed that the following committees and joint committees be included:-

#### 17 Appointment of Members of Outside Bodies

<u>RESOLVED</u> – That the appointment of members to outside bodies as set out in **Appendix B** to these minutes be approved.

#### 18 Review of the Constitution

Council considered a report of the Assistant Director – Governance and Monitoring Officer which sought approval of a revised Constitution, including Scheme of Delegation.

Council had approved the latest version of the Constitution in Summer 2014. Since then a number of legislative and internal changes had necessitated a further review and these were considered by Standards Committee on 26 March 2015. Standards Committee recommended the changes to Council, which included the following:-

- (a) Changes to the names and functions of scrutiny committees. The new committees were proposed to be known as *Growth*, *Communities and Organisation*.
- (b) Changes to Procurement Rules. The Public Contracts Act 2015 came into force at the end of February 2015 and the Council's Contract Procedure Rules had been amended accordingly. The new legislation governed all aspects of public sector procurement.

(c) Changes to procedures governing statutory officer dismissal. The Local Authorities (Standing Orders) (England) (Amendment) Regulations 2015 came into force on 11 May 2015 and removed the "statutory protection" afforded to the statutory officer posts of Head of Paid Service, Section 151 Officer and Monitoring Officer which required the appointment of a Designated Independent Person who made a binding recommendation to the Council on disciplinary matters brought against those officers. It was now a matter for the Council meeting to decide on the dismissal of a statutory officer having regard to the advice, views and recommendations of a Panel of at least two Independent Persons. These were the Independent Persons appointed under Section 28 of the Localism Act for the purposes of complaints against members under the Code of Conduct.

(d) Changes to councillors' access to information. The Local Government (Electronic Communications) (England) Order 2015 clarified the position with regard to members being summoned to meetings. Members may receive Council summonses by hard copy or by email to a specified address. They may change their minds about method of delivery at any point by notice.

In addition, the Government were consulting on new functions and responsibilities regulations but these remained outstanding. Details of the implications were set out within the report.

#### **RESOLVED** That:-

- (1) The revised Constitution attached as an appendix to the report, including the Scheme of Delegation, be approved.
- (2) Delegated power be given to the Monitoring Officer to make changes to the Constitution arising from any new legislation, administrative errors or conflicts in interpretation.

#### 19 Key Decisions Threshold and Decisions Taken Under Urgency

Council considered a report of Monitoring Officer, which advised of decisions taken under Special Urgency rules over the past 12 months and considered whether the threshold for Key Decisions remained appropriate.

A Key Decision was an executive decision which was likely to:-

- Result in the Council incurring expenditure which is, or the making of savings which are, significant having regard to the Council's budget for the service or function to which the decision relates; or
- Be significant in terms of its effects on communities living or working in an area comprising two or more wards within the District.

In determining the meaning of "significant" the Council must have regard to any guidance for the time being issued by the Secretary of State. The

Council decided that income or expenditure of £50,000 or more was significant.

Legislation required all Key Decisions to be publicised 28 days in advance and where this was not possible special rules applied. Where a Key Decision was required to be made and it was impractical to give at least five days notice permission from the relevant Scrutiny Chair had to be sought. The Council had not made any such decisions in the preceding 12 months. All Key Decisions were required to include provision for scrutiny call-in unless the relevant Scrutiny Chair had waived that requirement. This should only be done where any delay caused by the call-in process would seriously prejudice the Council's or the public interest. Details of Key Decisions taken under Special Urgency and of decisions where call-in was waived were set out in the report.

Finally, the report dealt with the threshold for Key Decisions which was currently set at £50,000. It was considered that this was sufficiently high enough to cover material expenditure without going so low as to hamper administrative efficiency. It was proposed that this threshold be maintained at the current level.

#### **RESOLVED That:-**

- (1) Those decisions where scrutiny call-in was waived be noted.
- (2) The decisions taken on Special Urgency be noted.
- (3) The threshold for Key Decisions be maintained at £50,000.

#### 20 <u>Disciplinary Process for Chief Officers and Deputy Chief Officers</u>

Council considered a report of the Monitoring Officer which provided a process for the consideration of capability and conduct issues for the Joint Chief Executive Officer, Directors and Assistant Directors, including processes for the statutory officers.

The report proposed to establish a Joint Employment Committee and a Joint Appeals Committee to deal with the initial and appeal stages of capability and conduct issues at both Councils. Suggested terms of reference were attached as an appendix.

The panels would consist of three members from each Council to be chosen proportionately by the two political group leaders, with the Council's Strategic Alliance partner Bolsover District Council to deal with disciplinary matters in relation to the Chief Executive, Joint Directors and Assistant Directors.

#### **RESOLVED** That:-

(1) Council establishes a Joint Employment Committee and a Joint Appeals Committee with the terms of reference attached to the report.

(2) The membership be chosen by the two Leaders under proportionality rules.

(3) Delegated power be given to the Assistant Director – Governance and Monitoring Officer to establish a hearings procedure for both committees.

#### 25 Annual Report of the Standards Committee 2014/15

Council considered a report of the Chair of Standards Committee providing an annual report on the work of the Standards Committee 2014/15.

Paragraphs 1.3 to 1.5 of the Annual Report detailed significant areas of work undertaken on the Ethical Standards Survey with District Council Members and officers and with parish/town councillors and clerks. It also highlighted that a further opportunity for training with parish/town councillors and clerks would be provided by the District Council following the elections in May 2015.

The Committee was advised that of the 16 complaints against the Council in 2013/14 no cases of maladministration were found and one complaint was upheld. The Annual Report also included the reports of the two Independent Persons appointed by Council, Mr Ian Daines and Mr Stuart Hooton.

The former Chair of Standards Committee passed on her thanks to the members of the Standards Committee, including co-opted members, the Council's Independent Persons and the Governance Team for their support of the past municipal year.

#### **RESOLVED That:-**

- (1) The annual report 2014/15 be approved.
- (2) A copy be provided to all the parish/town councils in the District and the Derbyshire Association of Local Councils to advise them of the work of the Standards Committee 2014/15.
- (3) A copy be included on the Council's website and on the members' portal and that it be subject of a press release to highlight the ongoing work of the Standards Committee.

#### 26 Future Arrangements for Independent Persons and Co-opted Members

Council considered a report of the Chair of Standards Committee, which set out future arrangements for Independent Persons and co-opted members on the Standards Committee following the May 2015 elections.

The Localism Act 2011 required that Councils appoint an Independent Person who must be consulted by the Authority before a decision was taken on a complaint against a Member regarding their conduct. The Council appointed Mr Ian Daines and Mr Stuart Hooton in July 2012 as its two Independent Persons, their terms of office to end in May 2015.

The Council now had an opportunity to review the above arrangements and decide whether to re-appoint or re-advertise for Independent Persons, taking into account the views of the Standards Committee, Council and the two individuals concerned. The Committee was advised that the Council had a constructive relationship with its two Independent Persons. Both Independent Persons had indicated a willingness to continue in their roles, and it was proposed that their terms of office be extended until May 2019.

Council was reminded that two non voting co-opted members who represented parish/town councils within the District had been appointed as part of its membership. This was a local decision intended to secure appropriate representation of the parishes/town councils on the Committee. Council had a number of options, it could:-

- Abolish the co-opted members' roles, however this would leave the parish/town councils without representation;
- Retain the existing two co-opted member roles;
- Reduce the number of co-opted parish/town council roles to one.

Council was advised that Standards Committee had considered this matter at their meeting on 26 March 2015 indicating its support for the retention of two co-opted members and for the proposal to hold fresh elections to these posts.

#### **RESOLVED** That:-

- (1) The Council notes the increased role for Independent Persons in relation to dismissal cases against the Council's statutory officers.
- (2) The terms of office of the Council's two Independent Persons, Mr Ian Daines and Mr Stuart Hooton, be extended until the end of May 2019.
- (3) The Council organise fresh elections for the two co-opted members of Standards Committee in line with the timetable set out in the report.

#### 27 NEDDC Local Authority Mortgage Scheme (LAMS)

Council considered a report of the Portfolio Holder for Housing, which sought agreement for an indemnity level for the Local Authority Mortgage Scheme (LAMS) in North East Derbyshire.

Cabinet had recently agreed to the development of a Local Authority Mortgage Scheme (LAMS) in the District to be administered by Capita Asset Services. The Scheme was aimed at first time buyers who could afford mortgage payments but not the initial deposit to help them get on the property ladder. Details of how the Scheme would work were set out in paragraph 1.3 of the report.

As part of the Scheme, the local authority set aside a sum of money to support a financial indemnity for the partner mortgage lender. It was proposed that the total indemnity be set at the lowest level agreeable with any lender agreeing to back the Council's Scheme. This was £500,000 and would enable the delivery of approximately 17 mortgages for first time buyers, meaning an average mortgage of £150,000.

<u>RESOLVED</u> – That the Council agrees to a maximum level of indemnity of £500,000 for the Local Authority Mortgage Scheme.
