### 632 Questions from Members under Procedure Rule No 9.2

In accordance with Council Procedure Rule No 9.2 members were permitted to ask the Chair of the Council or relevant Committee or the appropriate Cabinet member questions about Council activities.

### 633 <u>Motions from Members under Procedure Rule No 10</u>

No motions had been submitted under Procedure Rule No 10 for this meeting.

### 634 Review of Electoral Arrangements

Council considered Report No CE/01/15-16/DS of the Chief Executive and a presentation from Professor Paul Wiles, Lead Commissioner from the Local Government Boundary Commission (LGBCE) for England. Mr Wiles was present at the meeting along with Mr Tim Bowden, also from the Commission.

Council was advised that under Boundary Commission Guidance, where any local authority with a ward that had an electoral variance in excess of 30%, or any local authority where more than 30% of the wards had an electoral variance in excess of 10% from the average of that authority, it was necessary to give consideration to the need for a review. In North East Derbyshire one ward (Renishaw) currently had an electoral variance in excess of 30% of the average.

In carrying out their review, the Commission would have regard to three statutory criteria:-

- The need to secure equality of representation;
- The need to reflect the identities and interests of local communities; and
- The need to secure effective and convenient local government.

The purpose of the review was to address imbalances in the electoral variances in accordance with statutory criteria. In doing so, the Commission would decide the pattern of wards for the entire Council, including as follows:-

- Total number of councillors (Council size);
- Number of wards:

- Names of wards:
- Boundaries of wards.

Details of the timetable for the review were set out within the report. There were two key stages within the timetable, namely the submission of proposals relating to Council size and the subsequent pattern of electoral arrangements once the Council size had been determined by the Commission. Members were advised that any person or organisation may submit proposals relating to Council size and electoral warding arrangements.

In determining the right Council size, the Commission would consider the authority's decision making arrangements, its scrutiny and outside body arrangements and the representational role of councillors. Issues would need to be considered against future trends or plans as well as current arrangements.

Having considered the report, members asked questions and raised issues. Council was advised that the Chief Executive had enlisted the support of a former Association of Electoral Administrators Consultant, Peter Smith, to assist with the review.

<u>RESOLVED</u> – That Council delegate to the Chief Executive, following consultation with the Leader of the Council, power to:-

- (1) Co-ordinate the Council's response to the Local Government Boundary Commission's review of North East Derbyshire District's electoral arrangements.
- (2) Formulate and recommend to the Council submissions to the LGBCE, in accordance with the timetable, relating to the Council size and the electoral warding arrangements.
- (3) Advise the Council on the Local Government Boundary Commission's draft and final recommendations, as appropriate, during the review process.

### 635 <u>Devolution – Sheffield City Region and North Midlands Proposals</u>

Council considered report CE/02/15-16/DS of the Chief Executive which sought agreement of the Devolution Deal proposals for Sheffield City Region and the North Midlands and determination of the preferred membership status for the respective combined authorities.

The report set out the background and details of the themes within each proposed Devolution Deal, the current position and the proposed timetables. It summarised the potential governance arrangements and relevant statutory provisions and set out the short and potential long-term benefits to the Council as well as the significant risks and uncertainties going forward.

The proposals had been the subject of two member awareness sessions in October 2015 and February 2016.

During the debate on the report, it was moved by Councillor M Thacker and seconded by Councillor S Ellis that Council:

- (a) Note the significant work undertaken in the development of both Devolution Deal proposals and the key elements contained within each Deal document;
- (b) Endorse the Sheffield City Region Devolution agreement;
- (c) Endorse the proposed North Midlands Devolution agreement;
- (d) Determine the preferred 'membership status' option for the respective Combined Authorities as follows;
  - Option 1 Constituent membership of SCR Combined Authority and non constituent membership of proposed North Midlands Combined Authority
  - Option 2 Constituent membership of proposed North Midlands Combined Authority and non constituent membership of SCR Combined Authority,
  - iii. Option 3 Non-constituent membership of proposed North Midlands Combined Authority and SCR Combined Authority.
- (e) Authorise the Chief Executive, following consultation with the Leader, to continue discussions to (i) finalise the relevant constitutional provisions and voting arrangements for delivery and separation of Mayoral and Combined Authority functions across the two respective areas, and (ii) develop proposals for the overlapping economic areas,
- (f) Authorise the Chief Executive, following consultation with the Leader, to consent to the necessary enabling orders.

The report included results of the consultation process in relation to the proposals for Legal Services, as well as details of the progress on the job evaluation process.

### RESOLVED - That:-

- (2) The Joint Assistant Director of Governance and Monitoring Officer be renamed the Joint Assistant Director of Governance and Solicitor to the Council and Monitoring Officer.
