




1. When will you, or did you, change your standing orders?





2. Will you appoint a standing panel or make appointments when and if required?





3. How many Independent Persons will be on your Panel?




























16. Do you consider that the Chief Executive JNC terms and conditions currently guarantee an investigation by a designated independent person?




