# Clay Cross all set for Government decision for its share of the £3.6bn Towns Fund

North East Derbyshire have submitted their Investment Plan to the Government in a bid to secure their part of the £3.6bn Towns Fund.

The Plan was submitted to the Government on 30<sup>th</sup> October 2020 and was produced following a comprehensive period of consultation with residents and stakeholders over the summer and proposes a number of projects to be funded from the £3.6bn Fund.

Government officials will now appraise the proposals, with a decision on the level of funding for the town is anticipated to be announced early 2021.

Councillor Carolyn Renwick, Cabinet Member for Economic Development said, "We are incredibly pleased to have finalised our Investment Plan and submitted it to the Government".

"We have proposed a number of exciting projects which will revitalise the town, bring new jobs for residents and is a huge opportunity for great things to come for Clay Cross, subject to the Governments decision".

Gary Golden, Chair of the Clay Cross Town Board said, "We are delighted to sign-off the Clay Cross Investment Plan and agree to its submission to government. It is a hugely exciting time for the town with some fantastic projects being proposed to regenerate the area and bring new employment opportunities and a bright, sustainable future for Clay Cross".
