Planning Committee 21st September 2021

SUMMARY OF LATE COMMENTS/REPORT UPDATE

SUMMARY:

The applicant submitted amended plans removing the rooms in the roof however the application title was not updated to reflect this until 16th September 2021.

OFFICER COMMENTS:

As a consequence the title in the planning committee agenda does not reflect the application. Officers apologise for any confusion which resulted from this amendment and the title of the application has been amended within the uniform system and on the presentation to members in order to reflect the amendment.

SUMMARY:

Officers note that paragraph 4.2 of the report to members appears to have some text omitted. In the interests of clarity, the paragraph should read:

Highways Comments

The Highway Authority raised no objections to the above proposal as part of the initial outline application (ref: 18/00703/OL) and similarly to the subsequent full planning application (ref: 20/00170/FL) that is understood to have been refused. This application now seeking reserved matters consent to the outline application.

Reiterating previous comments, the applicant is not showing any control of the shared driveway from the site to Longedge Rise (the public highway), as part of the application site boundary. I presume your Authority is satisfied that an access for future residents will be available between the application site and the highway.

It is noted that a bin area for refuse and recycling is proposed to the side of the proposed turning area in the South-West corner of the site. However, given the distance from the public highway provision will need to be made for the collection of refuse bins on bin collection days, clear of the public highway. It is assumed that a refuse vehicle is unlikely to enter the private driveway and will operate a roadside collection service only. Facilities for the collection of bins, which does not restrict the operation of the driveway or inhibit pedestrian movement on the adjoining public highway will need to be considered. This could form a condition of any consent issued.

OFFICER COMMENTS:

A condition is included on the outline permission requiring the submission of a scheme of storage and collection of waste.

From a Highway standpoint there are no objections to the above proposal subject to similar conditions to those recommended as part of the outline application being appended to any consent in the interest of highway safety.

SUMMARY:

In response to the applicant submitting a Planning Statement, the following representation was received from Mr Knight:

At the time of writing although the agreed expiry date of 30th August 2021 has expired a new document called "Planning Statement" has appeared on the planning portal 1st Sept 21.

Its very misleading stating that its independent, leading people to think it may have been requested by the NEDDC as an independent planning statement, this is not the case as it has been requested by the applicant and is therefore very biased towards the planning application getting approval.

John Church is a well-known local freelance charted planner who often write papers in support of applicants planning applications and his position should have been clarified before the document was uploaded.

Yet another attempt to get this application in place, same old plan wrapped up differently.

OFFICER COMMENTS:

Officers would comment that it is not unusual for applicants' to submit planning statements in support of their applications. The statement has not been requested by officers and nowhere within it does it suggest that it has been. The planning statement is considered as part of the application alongside all the other submissions, the development plan and in this case any conditions laid out in the Outline application.
