

**1-22** Members had a wide ranging discussion on a variety of possible review topics. These topics included the establishment of an out of hours team within environmental health, similar to the CAN Rangers at Bolsover District Council (BDC); The Housing Management agreement with Rykneld Homes Ltd; and the District Council's provision for individuals with hearing disabilities.

The Overview & Scrutiny Manager provided background information on previous Scrutiny work undertaken on some of the areas raised. She also advised Committee that some of the topics discussed could come to future meetings as a stand-alone item if not chosen as the review topic.

There was a consensus that the case for the establishment of an out of hours team, or CAN Rangers, within Environmental Health would form the Scrutiny review topic.

Committee discussed what they would like to identify from the review. This included comparing the service offered by BDC, speaking to their CAN Rangers, viewing policies and procedures and comparing these with other Councils offering a similar service. Committee would also look at how North East Derbyshire District Council (NEDDC) resolves similar issues as well as any potential costs involved.

The Overview & Scrutiny Manager informed Members that she would investigate relevant officers who could provide an overview of current service provision and request their attendance at Communities Scrutiny Committee to discuss this area with members.
