CXT <u>Utilisation of Low Carbon Challenge Funding</u> B/63/

The Board received a report that detailed the utilisation of the Low Carbon Challenge Fund (LCCF) and recommended that the remaining funds be reallocated to Clay Cross Active and Town Centre Regeneration project. The report provided the Board with information regarding the state of the key projects ongoing in Clay Cross and the benefits that the additional funding, relocated from the LCCF, would provide. It was explained that a Project Adjustment Request (PAR) would need to be submitted to the Ministry of Housing, Communities and Local Government (MHCLG), and a decision would be expected from the Ministry within 20 working days following initial triage.

The Board discussed issues surrounding the reallocation balance, ongoing risks, and contingency levels. The Board felt that the reallocation of the remaining LCCF represented a practical decision.
