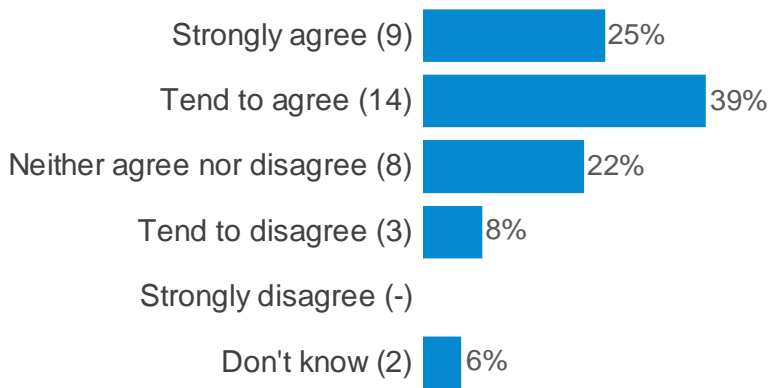

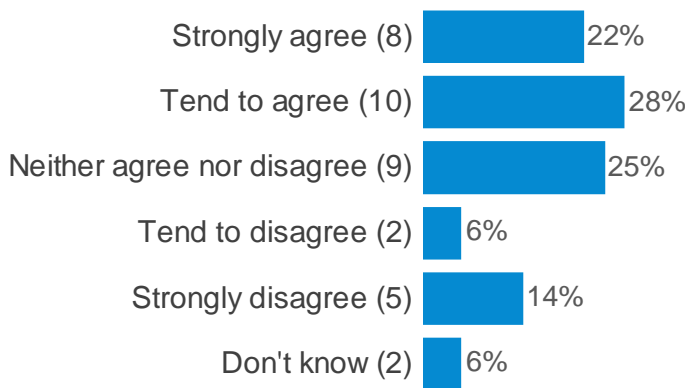
This report was generated on 14/06/21, giving the results for 37 respondents. A filter of 'All Respondents' has been applied to the data.

(Please choose one option only)

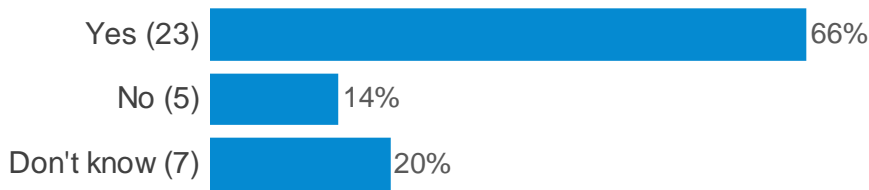


To what extent do you agree that the draft Sex Establishments Policy is fair to both residents and licensed premises?

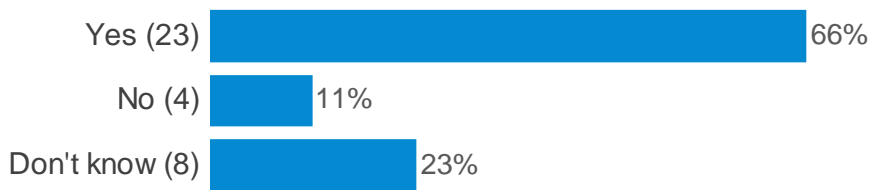

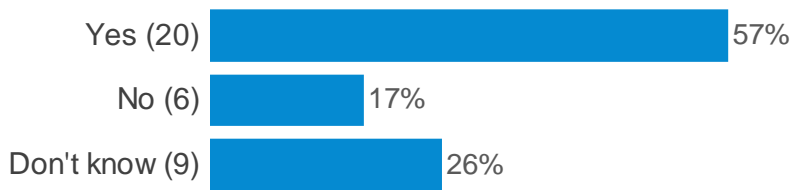
Local authorities have both mandatory and discretionary grounds for refusal of applications; are the distinctions between mandatory and discretionary made clear in our draft policy?



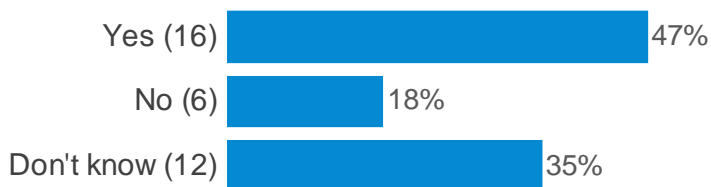
Are the mandatory grounds for refusal clear in paragraph 2.2?

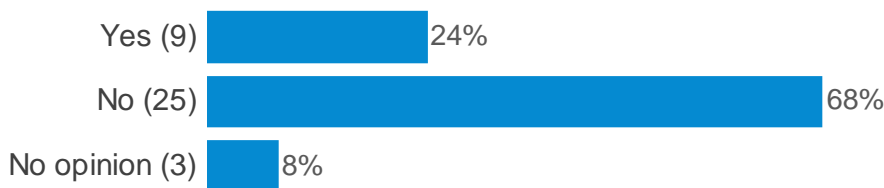
**Do you think it is acceptable to have a sex cinema in the following localities?
(Rural)**



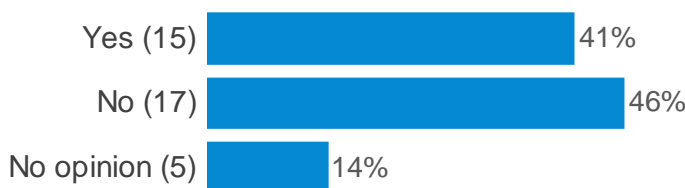

(Residential)**



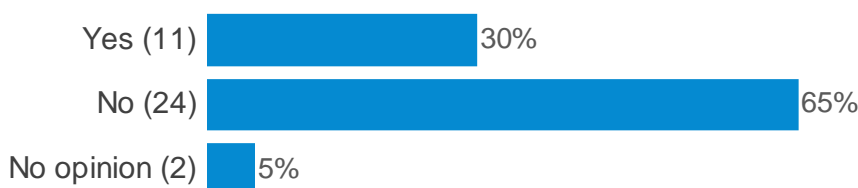

(Deprived areas)**



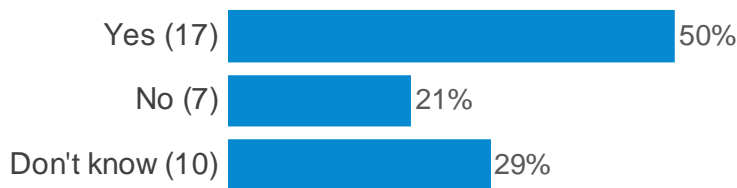

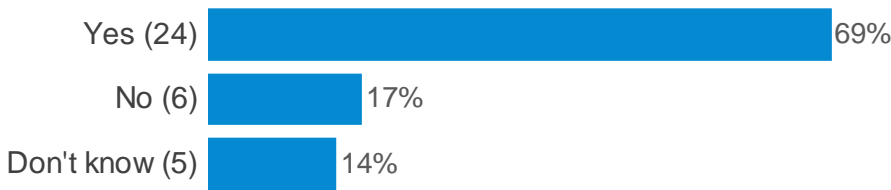


Do you think the enforcement section of the draft Sex Establishments Policy provides adequate information?

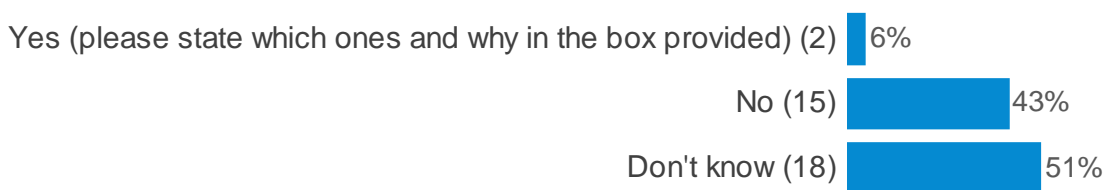

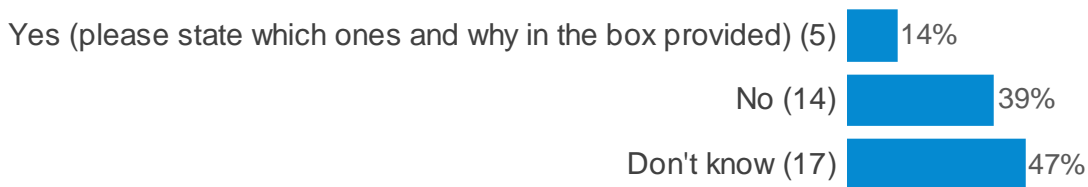

You state: "The Council is aware that sex establishments tend to be predominantly marketed to men. The licensing of these establishments must not encourage discrimination against women, especially those who work at or visit such premises or those who frequent the areas around such premises." The conditions must extend into the consequential increase in abuse against women as these institutions indirectly feed the negative tendencies that cause abuse. I would suggest that if there is EVER a case of this proven in law then the licence should be revoked.

I can't understand why our council is even considering letting this disgusting industry pedal it's materials. Please, please don't allow this.

1) I accept that this policy is necessary but fundamentally disagree with 2.1 that there can never be a moral reason to decline a licence. This is a moral issue. 2) 3.20 is good. Every year a fresh review should occur. 3) 2.8, 2.9 and the other 2 equivalent clauses is good. I would expect a robust generation of these exclusion areas from resident consultation. 4) 3.11 needs additional coverage as the reality is that planning applications can slip under peoples radar. I would make 21days significantly longer and I would take additional steps to communicate to all affected residents through direct email. These institutions play on depravity and encourage activities that ultimately result in evil actions against others. 5) Finally if a licence is provided then I would make it a condition to record everyone entering the premises so that should it be necessary the police can use evidence. 6) I appreciate being given the opportunity to respond. This policy is necessary but I hope there are never any such institutions in this council area.

The grounds for approval in the policy seem as bit bent towards refusing any applications, do feel that the questionnaire was also written so answers showed sex venues were unwanted as no option or scales could be added to answers eg location of venues, no option like industrial settings would be OK all the options were places that are more unsuited with no option of adding suitable places as mentioned.

Definitely reccomend having all of the above

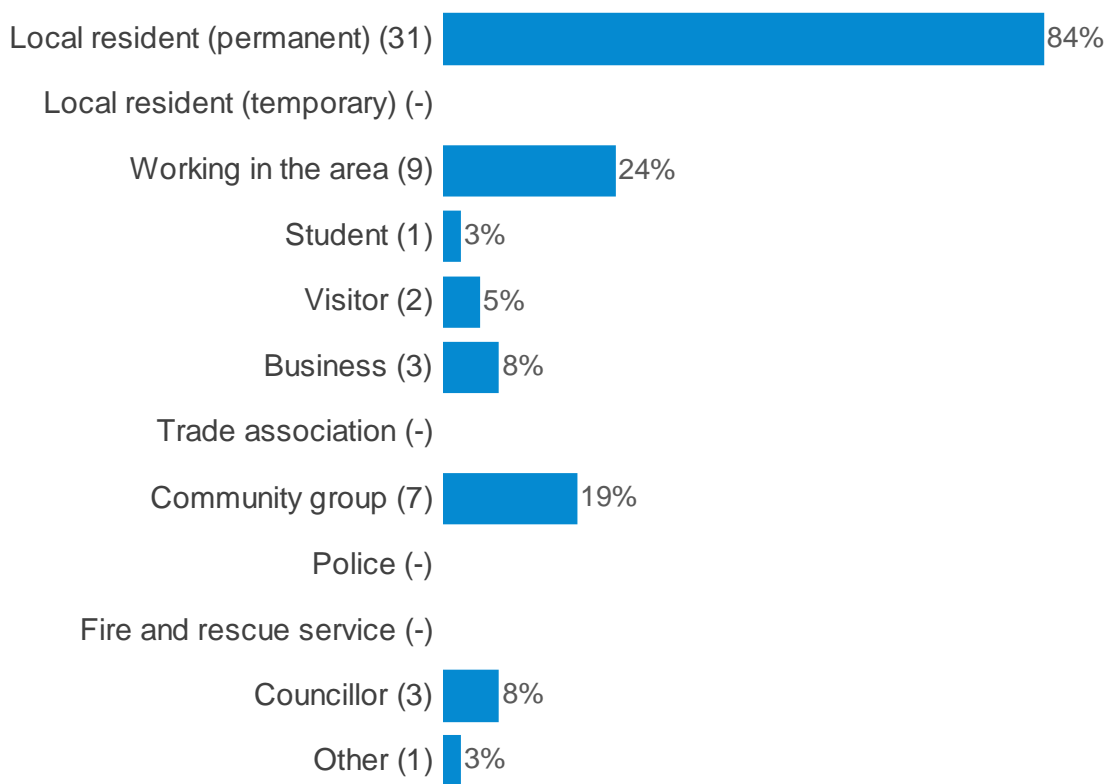

What is your age?

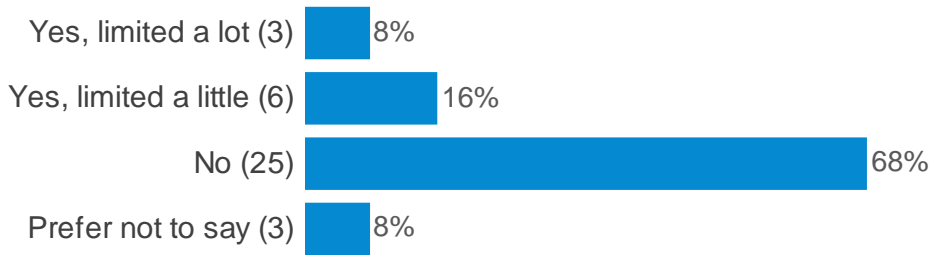


What is your current employment status?
