CAB/ Council Plan Targets Performance Update April to June 2021 (Q1 - 2021/22) 48/2

1-22 Cabinet considered performance against the Council Plan targets, for the first quarter of the 2021-22 financial year. Cabinet heard that nearly half of the Plan targets had been on track to be achieved. Members also heard that fewer targets had been affected by the Coronavirus (Covid-19) outbreak than in the previous quarter.

Cabinet noted that on Target ENV 08, a draft Climate Change Communications Strategy had been developed, which was now nearing completion. Cabinet was informed that Target ECO 20, ensuring that tourism was a focus for the Economic Development Team, was expected to be achieved in the next quarter. Members welcomed this. Cabinet was also informed that Target RES 11, to increase Social Media posts to at least 180 per quarter, was now well embedded. Consequently,

the report recommended that it now be monitored at a Service Plan level. Members endorsed the approach.

RESOLVED -

- (1) That Cabinet noted the quarterly outturns against the Council Plan 2019-2023 targets.
- (2) That the Target RES 11 *Increase social media posts to at least 180 per quarter* be now monitored at a Service Plan level.

<u>REASONS FOR DECISION</u> – To inform Cabinet of progress against the Council Plan targets and to bring to its attention specific achievements and areas of concern.

CAB/ Funding to Voluntary and Community Organisations - Summary of 49/2 Outcomes for 2020/21 1-22

The report to Cabinet summarised the Outcomes achieved by Voluntary and Community Organisations funded by the Council during the 2020-21. Members were reminded that these organisations were required to provide information on how their activities had helped to deliver the Council Plan 2019/23 goals and priorities and in particular, RES 21 - *Invest in voluntary and community organisations to assist over 20,000 vulnerable and disadvantaged households per year.*

Cabinet was informed that the Council had provided £136k of grant aid to these organisations during the year. Although opportunities to assist vulnerable people had been impacted by the Coronavirus (Covid-19) restrictions, they had still been able to use this grant aid to help nearly 18,000 vulnerable and disadvantaged households.

Cabinet discussed the report. There was a consensus that the Voluntary and Community Organisations supported by the Council had made an important contribution to helping vulnerable people in the District, in what had been very difficult circumstances. Members thanked them for their efforts and the important role which they had played in assisting North East Derbyshire's communities during the Coronavirus outbreak.

<u>RESOLVED</u> - That Cabinet noted the Outcomes achieved by those Voluntary and Community Organisations funded by the Council in the 2020-21financial year.

<u>REASONS FOR DECISION</u> – To monitor efficiencies and outcomes achieved by Voluntary and Community Organisations, commissioned to help achieve the Council's priorities.
