Licence fee review for Gambling Act 2005

Report No EMH/3/19-20/KR of the Environmental Health Manager

Purpose of the Report

• To review the licence fees charged by the Authority in respect of Gambling Act premises licences and annual fees.

1 Report Details

Background

- 1.1 The Licensing Authority have the power to set certain licence fees for premises where gambling takes place under the provisions of the Gambling Act 2005 ('The Act'). In essence the Council may set licence fees in respect of all premises that hold a premises licence.
- 1.2 Fees in respect of permits are set by statute and therefore have not been included within this report.
- 1.3 Members will no doubt be aware that the Council cannot make a profit from licence fees and cannot cross subsidise other areas of licensing. There have been a number of legal challenges against Licensing Authorities elsewhere in England and Wales which reinforce this principle.
- 1.4 The Act, at Section 212, permits the Council to recover costs associated with administering each licence type and also permits the authority, should they wish to do so, to charge differing fees for different classes of premises. The Gambling (Premises Licence Fees) (England and Wales) Regulations 2007 sets statutory maximum levels to prevent Licensing Authorities from charging excessive fees for the licences they issue. The statutory fee levels are set out in the fee table at Appendix 1.

- 1.5 The Licence fees in respect of Gambling Premises were last reviewed approximately five years ago.
- 1.6 The Authority currently licences the following numbers and types of Gambling Premises:

1.5 The legislation does not require the Authority to consult on any proposed amendments to licence fees with the public or members of the trade, however, it is considered best practice that a basic consultation exercise is undertaken. Should Members provisionally approve the revised fees then Officers will undertake a consultation exercise prior to the final adoption of the fees.

Any objections or comments received will be considered by Officers together with the Chair of the Licensing Committee before a final decision on whether or not to introduce the licence fees is taken.

- 1.6 The Council does not currently licence any large or small casinos. Therefore while the fees have been calculated in respect of these types of premises, Officers have very little information available from which they can determine them and therefore they are considered to be a 'best guess' at this time. Should the Council licence any casino premises in the future then the fees will be recalculated once more information is available to ensure that the fees are set at a level which do not exceed the costs incurred by the Authority.
- 1.7 The statutory maximum, current and proposed licence fees are set out in the table at Appendix 1.
- 1.8 Any changes to licence fees will have an impact on the levels of income for the Licensing Authority. Ultimately however, as has been stated earlier in the report, the Authority are not permitted to make a profit from licence fees.

Over the last few years the Council has received an average of less than one application per year for a gambling premises licence and therefore any income received from applications is extremely difficult to quantify.

A table is provided below to outline the variation in annual fee income that will occur should the proposed licence fees be adopted by the Authority:

5.1 Finance and Risk Implications

5.2.1 Failing to set licence fees in accordance with the statutory requirements may lead to a challenge against the Council's accounts. This may result in any unlawful licence fees having to be refunded to members of the trade.

- 6.3 Should objections be received then these will be considered by Officers in conjunction with the Chair of Licensing and a decision made whether or not to implement the licence fees as proposed.
