Purpose of the Report

- To advise Members of the outcome of the election for two co-opted members of Standards Committee.

1 Report Details

- 1.1 Following the May elections, the two appointed Co-Opted Members of the Standards Committee were no longer eligible. On that basis, and following procedures agreed by Council, and election by the Parish Councils was commenced.
- 1.2 Parishes were written to on two occasions in the Autumn, firstly to request nominations and then to ask them to vote for no more than two candidates. Eight parish councillors had put themselves forward.
- 1.3 The outcome of the vote was as follows:

- 1.4 With a tie for the second position, both candidates were invited to attend a drawing of lots to determine the appointed person. On the drawing of lots, Derrick Skinner was duly elected.
- 1.5 Derrick Skinner and Pat Coleman were therefore appointed to the Committee. Both Derrick Skinner and Pat Coleman have been inducted and are set to attend their first meetings on 19 February 2020.
